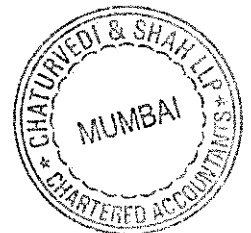

4. The Management is also responsible for ensuring adherence that the details in the Statement are correct.

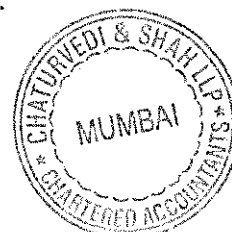


Auditor's Responsibility
